§ 131.01 DISORDERLY CONDUCT.

It shall be unlawful for any person to engage in conduct or behavior which disturbs the peace and good order of the village by clamor or noise, intoxication, drunkenness, fighting, or using obscene or profane language in the streets or other public places or otherwise violating the public peace by indecent or disorderly conduct or lewd or lascivious behavior.

§ 131.02 STREET GAMES.

It shall be unlawful for any person to play catch, bat a ball, or kick or throw a football, or to engage in any exercise or sport, upon the village streets and sidewalks. Nothing herein shall be construed to prohibit or prevent the Board of Trustees from ordering from time to time certain streets and public places blocked off for the purpose of providing a safe area to engage in such exercise and sport.

§ 131.03 OBSTRUCTION OF PUBLIC WAYS.

It shall be unlawful for any person to erect, maintain, or suffer to remain on any street or public sidewalk a stand, wagon, display, or other obstruction inconvenient to or inconsistent with the public use of the same.

§ 131.04 OBSTRUCTING WATER FLOW.

It shall be unlawful for any person to stop or obstruct the passage of water in a street gutter, culvert, water pipe, or hydrant.

§ 131.05 DISTURBING THE PEACE.

It shall be unlawful for any person intentionally to disturb the peace and quiet of any person, family, or neighborhood.

§ 131.06 CURFEW; AGE AND TIME.

It shall be unlawful for any person under the age of seventeen (17) years to loiter, idle, wander, stroll or play in or upon the public streets, sidewalks, highways, roads, alleys, parks, public places and public buildings, places of amusement and entertainment, vacant lots or other unsupervised places, or to ride in or upon, drive or otherwise operate any automobile, bicycle, other vehicle, in, upon, over, or through the streets, alleys, or other public places of the City, between the hours of:

- 1. Ten-thirty (10:30) o'clock P.M. to five (5:00) o'clock A.M. of the following day of all days of the week except on Friday and Saturday, and except that from the first (1st) day of June to the thirty-first (31st) day of August of each year the hours shall be from eleven (11:00) o'clock P.M. to five (5:00) o'clock A.M. of the following day on all days of the week except on Friday and Saturday; and
- 2. One minute past twelve (12:01) o'clock A.M. to five (5:00) o'clock A.M. on

each Saturday and Sunday, except that from the first (1st) day of June to the thirty-first (31st) day of August of each year the hours shall be from twelve-thirty (12:30) o'clock A.M. to five (5:00) o'clock A.M. on each Saturday and Sunday;

unless such person is accompanied by a parent, guardian or other adult person having the legal care and custody of such minor person, or unless such minor person is upon an emergency error or legitimate business, directed by his or her parent, guardian or legal custodian. (Ref. 16-246 RS Neb.)

§ 131.07 CURFEW; DUTY OF PARENT, GUARDIAN, ETC.

It shall be unlawful for the parent, guardian, or other adult person having the care and custody of a minor under the age of seventeen (17) years, to allow or permit such minor person to do any of the things prohibited by Section 6-327 of this Article, unless the minor is accompanied by his or her parent, guardian, or other adult person having the legal care and custody of the minor, or unless the minor is upon an emergency errand or legitimate business directed by his or her parent, guardian or legal custodian. § 131.08 CURFEW; PROCEDURE UPON ARREST; CONTROL OF MINOR.

Upon the arrest of any person for the violation of Section 6-327, the retention or continued custody of such person shall be had and determined in accordance with the provisions of Article 4 of Chapter 29 of Neb. Rev. Stat. (Supp. 1990) as the same exists and as may be hereafter amended.

§ 131.09 CURFEW; PENALTY.

Any persons violating the provisions of this Article shall, upon conviction be fined as follows: For the first (1st) offense, such person shall be fined not less than ten (\$10.00) dollars nor more than one hundred (\$100.00) dollars; for the second (2nd) and subsequent offenses, such person shall be fined not less than twenty-five (\$25.00) dollars nor more than one hundred (\$100.00) dollars.
